### FOREIGN NATIONALS/ CHILDREN OF INDIAN WORKERS IN THE GULF COUNTRIES / NEPAL CITIZENS UNDER SUPERNUMERARY QUOTA

#### I] About RV College of Engineering:

RV College of Engineering (RVCE), established in 1963, is a constituent institution of Rashtreeya Sikshana Samithi Trust (RSST). It's an Autonomous institution affiliated to Visvesvaraya Technological University-Belagavi, currently offers 15 bachelor's, 14 master's programmes and 15 research Centres in science and engineering. RVCE is ranked 96<sup>th</sup> in the country by the National Institutional Ranking Framework (NIRF: 2023), QS-IGUAGE-Diamond University Rating (2021-2024) and ranked 1501+ in The World University Rankings 2023 (801+ Ranking in Computer Science and 1000+ in Engineering).

RVCE has to its credit over 1600 national and international journal publications, 70 filed patents, out of which 59 were published patents, 38 granted patents, and over Rs. 35 crores of sponsored research projects and consultancy in the last five years. The institution has over 350 qualified teaching faculty, 235 technical and administrative staff with more than 6,000 students on campus.

#### II] Eligibility Criteria:

10 + 2 pattern of education which is equivalent to Pre-university of Karnataka, India with Physics, Mathematics along with Chemistry / Computer Science / Electronics / Biology as optional with English as one of the languages of study and obtained a minimum 50% of marks in the optional subjects

- NRIs- Children of Indian Workers in the Gulf Countries are eligible for NRI Quota (as per The Gazette of India – 2004).
- Foreign Nationals – Citizens of all countries other than India. (As per The Gazette of India – 2004).
- PIO – Person who are citizens of other countries (except Pakistan and Bangladesh) who at any time held an Indian Passport, or who or either of his parents or any of his grandparents was a citizen of India by virtue of the provisions of the Constitution of India (as per the Gazette of India – 2004).

#### Definitions:

- "Overseas Citizen of India (OCI)": Means a candidate/person registered as an Overseas Citizen of India as declared by the Central Government under section 7A of the Citizenship Act 1955 and includes Persons of Indian Origin (PIO).

**Explanation:** For the purposes of this clause, all the existing Persons of Indian Origin (PIO) cardholders registered under notification of the Government of India, Ministry of Home Affairs No. F. No. 26011/04/98- F. I dated 19th August 2002 and shall now be deemed to be Overseas Citizens





of India (OCI) card holders by virtue of Notification of Government of India, Ministry of Home Affairs, No. 25024/9/2014-F.I. Dated 9th January, 2015.

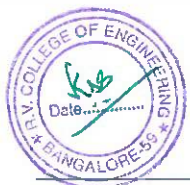
- **"Persons of Indian Origin (PIO)"**: A Person having foreign citizenship (except Pakistan and Bangladesh) without "NRI" status, who holds a Foreign Passport at the time of sending application, consideration for admission and during the period of his/her study, and he/she or anyone/both of his/her parents or anyone/both of his/her grandparents is (or was)/are (or were) citizen(s) of India by virtue of the provisions of the Constitution of India or Sec. 2(b) of Citizenship Act, 1955 (Act No. 57 of 1955).
- **"Foreign Nationals"**: Means Citizens of all countries other than India, who are not of Indian origin as defined under PIO.
- **"Foreign Student"**: Means Foreign Student in this context shall be defined as the student who possesses a foreign passport.
- **Children of Indian workers in the Gulf Countries**: The children of an Indian who is working in Gulf Countries under relevant working visa.
- **"NRI"**: Non-Resident Indian as per the definition given in the section 6 of the Income Tax Act 1961.
- **"NRI Candidate"**: Means a candidate who is a child/ward of the person who has the 'NRI status' as defined under section 6 of the Income Tax Act.

### III] Documents Required for Foreign Nationals/ Children of Indian Workers in the Gulf Countries Under Supernumerary Quota

- 1) Employment certificate of Father / Mother from the employer stating working from to till date (Minimum 5 year of service is compulsory) for students taking admission under NRI quota.
- 2) Valid passport and Visa copies of parent and student (if student studying in India, passport and visa copy not required) Qualifying marks sheet of student.
- 3) HSSC/XII Marks Sheet / "A" Level or equivalent certificate examination passed / appeared with English, Physics, Chemistry & Mathematics as essential subjects. (if studied 10+2 other than Indian Boards then Equivalent certificate has to be obtained from **ASSOCIATION OF INDIAN UNIVERSITIES (AIU), New Delhi.**)
- 4) SSC/X Marks sheet / "O" level certificate or equivalent certificate.
- 5) School / College Leaving / Transfer Certificate.
- 6) Migration Certificate.
- 7) VISA (Either working / business) of NRI.
- 8) Employer Certificate of NRI.
- 9) Passport copy of NRI / Guardian of NRI / Passport of the Candidate.
- 10) Letter from Indian embassy in proof of NRI status.
- 11) RP (Residential Permit) for Foreign students.

#### NOTE:

- All the international students are advised to register with FRRO within 14 days of arrival in India except students from Nepal and Bhutan and obtain Residential Permit.

- You have to apply for visa extension one month before the expiry date of the visa.
